• Structure of the Entrance Examination

3) The AIPET- PIMS-2025 examination will be conducted in English language for all faculties.

**a) For Entrance Examination, there will be two Papers
i e. Paper -1 and Paper – 2**

Paper - 1: Research Methodology of 100 marks of 2 hrs, with MCQ's.

Paper - 2: Specific Subject Test of 100 marks of 3 hrs.

- i) Multiple-Choice Questions covering relevant subject in the faculty.
(MCQ's) = (20 x 1=20 Marks)
- ii) Long Answer Question (LAQ's) = (3x20=60 Marks.)
- iii) Short Answer Question (SAQ's) = (2x10=20 Marks)

b) Standard of Passing:

- i) Candidate has to appear for Paper – I & II. He/she has to pass **separately** in Paper I & II. The passing percentage is 50% in Paper I & II separately. (45% of passing for the candidates belonging to SC /ST and DT /NT /SBC /OBC ((Non – Creamy Layer categories) and differently abled followed by Oral interview (Subject-wise syllabus will be uploaded on website accordingly).
- ii) After passing the Entrance test candidate has to appear for Oral/ Interview before the Interview Committee.
- iii) Provisional merit order will be prepared based on the combined merit of entrance test and oral/ interview performance (70:30 weightage or as per UGC norms notified) and copy of the same will be published on the notice board of Deemed to be University.

c) Fees for Entrance Test:

- iii) Application Form fee : Rs. 3050/- (Late fee will be Rs-100 per day)

d) Payment of Entrance Test Fees:

The student will have to pay the fees through online mode.

e) Eligibility:

For admission to the Ph. D. Programme in a related subject in the Faculty, applicants fulfilling any of the following criteria shall be treated as eligible:

- I) **Medical Faculty:-** Candidate with MS/MD/DNB/DM/M.ch, Medical P.G. Diploma or equivalent Master Degree awarded by a University recognized by NMC(Formerly MCI) is eligible for Ph.D. Course.
- II) **Dentistry Faculty:-** Candidates with MDS degree of Dental P.G. Diploma awarded by state/ Central Government/Deemed to be University recognized by DCI are eligible for Ph.D. course in Dentistry.
- III) **Other Than Medicine & Dentistry Faculty.**
 - i) Candidates are eligible for applying Ph.D. program in this University, having passed Post Graduate Degree (Master Degree) Examination in concerned subjects as listed in Annexure-I with at least 55% marks.
 - ii) relaxation of 5 % marks from 55% to 50% may be allowed for those belonging to SC/ST/DT/NT/OBC (Non – Creamy Layer) differently – abled and other categories of candidates as per the decision of the UGC from time to time, or for those who had obtained their Master's Degree prior to 19th September, 1991. The Eligibility marks of 55% and the relaxation of 5% to the categories

mentioned above are permissible based only on the qualifying marks without including the grace mark procedures.

iii) Post Graduate Degree obtained through distance education from the Open University will not be considered.

iv) The admission will be confirmed after the Ethical Clearance.

v) Fee Structure :-
