3. Total Fees Payments (DD)

Eligible candidate present without original documents and fees will not be allowed to register. **Hence candidates are requested to present alongwith original documents & payment of full fees as mentioned below.**

Merit List will be prepared of registered candidates at PIMS as per above schedule and admission will be given as per merit only. You will have to remain physically present yourself for admission along with the required Original Certificates and Demand Draft for payment of full fees as mentioned under clause & Fee Structure .

Your absence will result in instantaneous cancellation of your claim for admission.
