<u>GUIDELINES FOR THE REPORTING OF POSTGRADUATES (MD/ MS/ MDS) TO THE</u> <u>CONSTITUENT INSTITUTES OF PRAVARA INSTITUTE OF MEDICAL SCIENCES (DU)</u>

With reference to the urgent notice received from DGHS wide letter no. Ref. U-12021/44/2019/45-MEC dated 12/06/20 and directions from Ministry of Health and Family welfare dated 09/06/20.

All the post graduate students who have been allotted postgraduate seats through Round-I NEET 2020 counselling in Rural Medical or Dental college of Pravara Institute of Medical Sciences (DU) will be reporting to the institute from 15th - 22nd June, 2020 onwards.

In order to facilitate the smooth functioning of the same during this adverse situation of COVID 19. Following guidelines are put forward in accordance to the local authority directives for the reporting candidates'/PG students from the out stations. These guidelines will be for all the candidates reporting and joining the allotted institute under PIMS-DU:

- 1. All the candidates reporting will enter through GATE NO.2 for reporting / joining and will report to the admission section in NEW LECTURE HALL COMPLEX.
- 2. Candidates reporting should have the allotment letter along with him/her for entry through GATE NO.2. <u>The allotment letter will be considered as the entry pass from gate no.2 by the **security department of PMT**.</u>
- 3. All the candidates and parents entering the campus should be wearing Face mask and Face shield (Both compulsory). These are the mandatory requirement for entry in the campus. (Security department of PMT.)
- 4. The security department will guide the candidate for the place of parking and reporting.
- 5. Only one parent will be allowed with the candidate to enter the reporting premises i.e. admission section in **NEW LECTURE HALL COMPLEX.**
- 6. Physical distancing as per the COVID prevention guidelines will be mandatory in the campus and will have to be followed by all.
- 7. All the reporting students will be screened (thermal) at the reporting venue well as at the gate of the boys' hostel No.1and then rooms will be allotted separately for the Boys and girls for isolation in the same hostel.
- 8. All the candidates joining will be directed for Hostel Quarantine in Boys Hostel No.1.
- 9. All the students will be screened for the Covid-19 using TRUNAT machine for which the students have to pay the charges (Rs. 2200=00, Two thousand two hundred only) for the Covid testing as per the rules of PRH, Loni. The account facility will be made available at the Reporting venue.
- 10. The OPD file of the candidate required for TRUENAT testing will be made through **MRD section** at the reporting venue. With receipt of testing fee attached in the file.
- 11. The swabs for the screening will be collected from the Boys hostel no.1 at 10 am and 3:30pm every day till the admission and reporting process is completed. This task will be coordinated by **Department of Microbiology and Deputy MS from Casualty.**

- 12. Once the screened student's result is negative for Covid -19 the respective student will be allowed to go to his/herallotted room of his/her hostel The above transit will be coordinated by the **AOs and hostel rectors under the guidance of chief rectors**.
- 13. **The candidate will join** hospital duties through his department under the supervision of respective Head of the Departments as per rules of the constituent institute.
- 14. If unfortunately if the candidate is reported to be positive for covid 19 he / she will be treated at Dedicated Covid hospital ,Loni under the local health authority supervision.
- 15. Food arrangements will be made in the boys' hostel from the institute for the candidates from 16th June 2020 onwards.
- 16. PG students will not be allowed to come out of the room except for food and shall remain inside the hostel, until the reporting of covid testing is received.
- 17. Those PG students not adhering to the guidelines will be handed over to the local health authorities and have to go for the local institutional quarantine as per the rules laid down by the District authorities.
- 18. All the reports of TRUENAT testing will be submitted daily though the nodal officer of PRH, Loni to the Taluka and Local Government Health Authorities.
