Bond will be executed between candidate and respective institute, the candidate is required to deposit security deposit of Rs. 500,000/- (Rs. Five Lakhs only). The security deposit will be forfeited if candidate failed to serve for one year after passing. The bond/agreement need to be executed at the time of joining the course.

Whereas PIMS is Running Rural Medical College, Rural Dental College (Hereinafter referred to as said college) registered under the Bombay Public Trust Act 1950 and Societies Registration Act 1860 and the Trustee & Secretary is the overall day to day executive authority of the Management of The PIMS.

And whereas the above named PIMS deemed University is established under section (3) of the UGC Act 1956 and situated and working for rural people at Loni and surrounding rural area in Ahmednagar District. Therefore for serving rural people the management of PIMS decided that to after successful completion of the post graduation students from PIMS deemed university constituent colleges to serve in the concern colleges for one year to serve rural people.

And Whereas the above named student has applied in writing on the prescribed application for admission for MD/MS Degree course and certified that the entries made in there are true and correct to the best of his knowledge and whereas the said student is unable to remit and pay the prescribed fees by the deemed University. The student himself requested the PIMS authorities and voluntarily agrees himself to serve with PIMS for 1 year continuously immediately after his/her successfully complete on the said degree course on the following terms and conditions and covenants mentioned below:

NOW THIS AGREEMENT WITNESSETH AND IT IS HEREBY AGREED DECLARED RECORDED AND CONFIRMED BY THE PARTIES HERETO AS UNDER:

1. That the student is selected provisionally subject to approval of the deemed university.
2. That the said 'for MD/MS course student' will continuously serve with the Pravara Institute of Medical Sciences Rural Medical College and Hospital Loni for a period of One year from the date of his/her successful completion of course.

3. That if the "student" fails to serve the Pravara Institute of Medical Sciences for a period of One year as mentioned in clause No. 2 above or commits any breach of this agreement and or if not join the service or he/she left the service after joining on his/her own before expiry of said period or found negligent in discharging his/her duties or if the performance found unsatisfactory to the belief of the Deemed University or if there is any disciplinary action against his/her in which he/she would found guilty in that event the said student has to pay Rs. Five lakhs towards liquidated damages.
4. Further, in view of the service guarantee the Student has Agreed to Provide service deposit of Rs. 5,00,000 ( Rs. Five Lakhs Only) to the satisfaction of Trustee and Secretary of Pravara Institute of Medical Sciences . The candidate failed to observe the terms and conditions of this agreement, PIMS authorities have right to forfeit service deposit amount.
5. The said student is hereby declared that the said student is abide to observe the rules and regulations and discipline with regular attendance of the said Rural Medical college /Rural Dental College and in case of failure in this respect the decision of the management will be final.
6. That the said student will have to follow all the rules and regulations of the Pravara institute of Medical Sciences/PIMS.
7. During the substance of this agreement if there will be any dispute in respect of this agreement, the decision of "the PMT" will be final and any legal action will be subject to the jurisdiction of Rahata court.

This agreement has been executed by and between the parties hereto with their free consent, without any coercion and undue influence, fraud, misrepresentation. The student voluntarily and his free consent agreed the terms and conditions of the agreement since those are beneficial to the interest of the student.
